Subject: Information and Registration Details for the Event

Dear member of the PDSA,

In this memo, you will find the main details of the event.

### General Information

- 1) The National Championship will be held only if Provincial and Federal governments allow us to do so for public health reasons. CDSA has the right to change the dates for a shorter event or to cancel at anytime eight weeks prior to the event start date.
- 2) The technical regulations and the preliminary competition schedule are available on the [CDSA website](#).
- 3) Participants in the National Championship and CDSA sanctioned competitions must be:  
*'Deaf, defined as a hearing loss of at least 55dB pure tone average (PTA) in the better ear (three-tone pure tone average at 500, 1000 and 2000 Hertz, air conduction, ISO 1969 Standard)'*  
–Reference: ICSD Regulation

A participant attending their first deaf sports competition must send a copy of their audiogram **no later than August 15 2021** to [gigi.fiset@assc-cdsa.com](mailto:gigi.fiset@assc-cdsa.com) . The CDSA office will confirm their eligibility.

### Registration details

- 4) The event will go ahead only if there is a minimum of three teams in the women's category and minimum of the four teams in the men's category. If the numbers are insufficient, CDSA has the right to select the national team representatives in a different format during the National Championship.
- 5) There is no registration fee for the Championship. Players must register directly with their PDSA no later than **September 1<sup>st</sup>, 2021**.
- 6) Only the PDSA will contact CDSA by email at [gigi.fiset@assc-cdsa.com](mailto:gigi.fiset@assc-cdsa.com) to provide the list of registered players and/or teams. If there are interprovincial teams being formed, each concerned PDSA must inform CDSA.

### **CDSA Financial Assistance**

- 7) Only players from PDSAs located outside of Manitoba will be eligible for CDSA financial assistance.
- 8) Local transportation and accommodation are provided by CDSA for free **upon request**.
- 9) Local transportation provided **from/to airport to/from hotel only** on the arrival and departure days (dates will be confirmed during the week of September 6, 2021)
- 10) Accommodation will be at the Stampede Inn hotel in Morris. The hotel is located only a few minutes walking from the Canadian Championships. CDSA booked a block of 15 rooms.
- 11) To benefit from CDSA financial assistance (local transportation and accommodation), the PDSA must request it when providing players' registrations to [gigi.fiset@assc-cdsa.com](mailto:gigi.fiset@assc-cdsa.com) no later than **September 1<sup>st</sup>, 2021**. We will operate on the principle, 1st request for accommodation / local transport and 1st served.

### **Financial Assistance for Curling Players Studying Full-Time**

- 12) Only players from PDSAs outside of Manitoba are eligible for financial assistance for students.
- 13) LTAD financial assistance is available from CDSA for full-time and part-time students (min. 2 courses). The financial assistance would cover a portion of the airfare cost.
- 14) The student must be registered as a full-time or part-time student for the 2021 Fall semester.
