Here is an overview of upcoming administrative procedures:

Athlete safety and the COVID-19 pandemic

- 1) All players and coaches without exception have presented their proof of vaccination to the CDSA— thank you one and all! Our athletes' safety is important to us.
- 2) All players will get two free masks sporting the CDSA logo and two small containers with water-alcohol solution. Please use them whenever needed during your stay in Morris.
- 3) To maximize safety, players staying at the Stampede Inn in Morris will get their own room, provided by the CDSA. For the sake of safety, please don't socialize or invite others into your room.
