Subject: Teams confirmed for the Canadian Curling Championship in Morris, Manitoba

## 1) Confirmation of the teams

The CDSA regrets to announce that the women's event is cancelled.

For the men's event, we have received four (4) team entries. After verification of the eligibility criteria (2a. & 2b.) of the technical regulations, the CDSA confirms that all registered teams are eligible to participate in the Canadian Championship.

The four confirmed teams are:

Team Novak (AB/SK)
Team Morton (ON)
Team Comte (MB)
Team Lavallee (MB)

The list of teams and players' names-can be found on the CDSA website.

#### 2) Situation regarding Team Novak (AB/SK)

#### a. For the Canadian Championship

Team Novak is eligible to participate in the Canadian Championship. Should Team Novak win the championship, they will receive the gold medal.

#### b. To represent Team Canada

As per rule 2a., all players have <u>legal resident status</u> but two of the players do not have a Canadian passports. Should Team Novak win the championship, they will not be eligible to represent Team Canada.

## c. Certification by the Provincial Deaf Sports Association

Given the rules stated above, the Alberta Deaf Sports Association understands and agrees that should Team Novak win the championship, all team members of Team Novak would not be eligible to represent Team Canada.

#### 3) Schedules and Technical Regulations

The event will start on Friday April 21<sup>st</sup> with a pre-event practice for all teams at 8:00am. For complete schedule details and updated technical rules, please consult the CDSA website.

The Team Meeting document will be shared with teams prior to the team meeting one week before event. It is the team's responsibility to read the document prior to attending the meeting as there will not be time to cover the entire document during the meeting. Any questions the teams have will be addressed at the meeting.

#### 4) Team Representative

We ask that each team send the name of your team representative to <a href="mailto:gigi.fiset@assc-cdsa.com">gigi.fiset@assc-cdsa.com</a> by March 15. The responsibilities of the team representative are:

- Communicate all necessary information from the CDSA to other team members;
- Ensures that each team member understands the CDSA Code of Conduct and Ethics Policy (#30-06);
- Holds medical information and emergency contact information for each team member;
- Make a protest, if appropriate, on behalf of the team to the CDSA Technical Committee.
   Each protest must be made within a reasonable time and accompanied by a non-refundable fee of \$100 to the CDSA.
